RESOLUTION ADOPTING AMENDED BUILDING DEPARTMENT FEES

WHEREAS, the Town of Eaton, Colorado (the "Town") is a municipal corporation duly organized and existing under the Constitution and laws of the State of Colorado; and

WHEREAS, the Town Board of Trustees ("Town Board") constitutes the legislative body of the Town with authority to set the policies of the Town; and

WHEREAS, Section 6-1-12 of the Eaton Municipal Code provides that building department permit fees may be amended by resolution of the Town Board; and

WHEREAS, based on consultation with Jonathan Gesick of ProCode, Inc., the Town's Building Official, the Town Administrator recommends that certain building department fees, including building permit fees, over the counter one-stop fees, electrical permit fees, administrative fees and other miscellaneous fees, be increased to offset the Town's cost of providing building department services, as set forth on the fee schedule attached hereto and incorporated herein by reference as **Exhibit A**; and

WHEREAS, the Town Board finds that the amended building department fees are reasonable and directly related to the Town's cost of providing the required services and that adoption of the amended fees is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF TRUSTEES OF THE TOWN OF EATON, COLORADO, THAT:

Section 1. Commencing on January 1, 2021, the Town's building department fees, including building permit fees, over the counter one-stop fees, electrical permit fees, administrative fees and other miscellaneous fees, are hereby amended and adopted as set forth on the fee schedule attached hereto and incorporated herein by reference as **Exhibit A**.

<u>Section 2</u>. This Resolution shall supersede prior resolutions regarding the same subject matter.
